The Village of New Paltz is undertaking a NYS Office of Community Renewal Small Cities Community Development Block Grant (CDBG) Project. NYS CDBG Grant Project #793PR80-21 in the amount of \$918,750 is being used to replace sanitary sewer lines and manholes in order to comply with a NYSDEC Order on Consent.

In accordance with the CDBG Citizen Participation requirements, a public hearing is being held in order to review the performance and status of activities and to identify future Community Development activities for the Small Cities CDBG Program. This second hearing is in addition to a public hearing that was held during development of this project prior to submission of the Small Cities CDBG application. At this hearing the Village will review the amount of project #793PR80-21 CDBG funds that were available, provide a listing of activities that were undertaken with CDBG funds, the amount of CDBG funds made available for activities that benefit the LMI National Objective and progress towards program goals and objectives as outlined in the original application.
